1) What is your motivation for running for this office?

5) How will you establish a good working relationship with the elected Mayor to ensure the City's success?

The school system has to be at its highest peak in order for the city of Birmingham to flourish in economical and residential growth and prosperity. In essence, communication, visibility and accessibility will create a good working relationship with the Mayor

6) Recognizing that education plays a vital role on the present and future of a city's economy and job growth, what are your plans for Birmingham City Schools to be seen as one of the top education institutions in the nation?

My plans for Birmingham City Schools to be seen as one of the top educational institutions nationwide and worldwide are as follows: (1) Create and sustain at least 5 months of operating expenses which equates to \$85 million dollars_(2) Ensure that every teacher in the Birmingham City School System is Highly Qualified and Professionally Certified, (3) Ensure that every child graduates and is career ready for postsecondary education, the military, or the workforce, (4) Have top notch education and parity in all schools thus eliminating the potential of failing schools being in our district, (5) Create a healthy and engaging teaching and learning atmosphere in enhancing a safe school climate, (6) Showing tremendous leadership in engaging parents and stakeholders inclusively and collaboratively in the educational process, and (7) Create and hold Superintendent accountable for implementing Board Policies that are sound, legal and not an infringement of human rights, thus avoiding, millions in litigation fees and decimating the general fund budget, These are my plans for Birmingham City Schools to be seen as one of the top educational institutions nationwide and globally.

7) What do you see as Birmingham City Schools' greatest challenges and assets?

I see Birmingham City Schools greatest challenges in the areas of financial growth in attaining excellence, gaining the public's trust and respect as a result of poor academic standing, transparency in decision making, ceasing the number students leaving the district on an annual basis, having highly qualified and certified teachers in every classroom, maintaining stability at the Superintendent's position and high level parental involvement. The assets that I see in the Birmingham City Schools are as follows: (1) Meeting the state requirement of 1 month's reserves in the budget, Excellent Career Tech Programs in the High Schools, (3) Talented teachers and administrators, (4) Availability of Resources throughout the community for excellent learning and teaching, (5)Partnership with UAB in enhancing opportunities for students. These are in essence the greatest assets and challenges I see in the Birmingham City School System.

8) What goals do you hope to achieve if elected?

The goals that I would like to see achieved in collaboration with my fellow school board members are as follows:(1) Financial Stability with at least a 5 month surplus equaling 85 million dollars, (2) Every child being taught by a highly qualified and certified teacher, (3)100% Graduation Rate for High School Students, (4) All schools performing above grade level, thus eliminating failing schools from being in our district, (5) 95-100% Parental involvement at all schools, (6) Stability at the Superintendent's position, and last, but not least, becoming known as a world class school system where our children will be prepared to successfully compete against the best of the best worldwide. These are some of the goals I would like to see achieved in the Birmingham City School System

9) What in your opinion is the reason for Birmingham City's failed schools and what are your plans to ensure the success of Birmingham City Schools?

Birmingham City Schools is failing because of lack of leadership at the school board level. The school board has shown it is not on one accord, has different agendas and decisions are clearly not being made in the best interest of children. In order for a school district or any organization to be successful you must have collaborative leadership. I would use my skills experience, and knowledge as a leader to encourage and practice working collaboratively. I would certainly make sure that every recommendation that comes to the Board has a rationale that is in the best interest of children and one we can afford. I would use my experience to serve as a safety net against flawed educational recommendations and at the same time I will use my knowledge and experience to mentor and guide our newly appointed Superintendent who is still learning the position. Last, but not least I will not micromanage the Superintendent, but hold her accountable for carrying out the policies and curriculum to a standard of excellence. These are in essence my plans to ensure success in the Birmingham City School System.

10) What will you, as a board member, do to assure that teachers have the support and materials needed to successfully assist students in meeting state standards?

The school board has a fiduciary responsibility to the employees and citizens of the city in regards to having a balanced budget. As a board member, I will make sure that we have a priority in the budget for instructional materials and professional development. Next to personnel these categories will have the most funds allocated to it from a percentage standpoint. If you allocate the monies for instructional supplies and professional development, then this should negate teachers from being void or subpar in those areas. I will encourage our Superintendent to seek all external sources in terms of discretionary monies, grants, etc. in meeting the instructional and academic needs of teachers and schools. I will also encourage my fellow board members to add this component to the evaluation process of the Superintendent as well. This is in essence what I will do __to ensure that teachers have support and materials needed to successfully assist students in meeting state standards

11) How would you balance your decisions as a member of the board with the input of parents and teachers?

All concerns and suggestions from parents and teachers should be directed to the proper protocol first and foremost. However, if I am made aware of concerns and suggestions, it is my job to make the superintendent aware of these concerns and suggestions. It is imperative for teachers and principals to resolve conflict and create an open and caring environment for parents and employees to communicate with them to enhance their respective schools. If success does not come at that level it should go to the central office level to the appropriate supervisor and ultimately the Superintendent. If all fails there, then the school board is the last resort at the local level to bring resolution to the matter. As a school board member, I will hold accountable and evaluate the superintendent on her effectiveness in listening, resolving conflict and the like and I will always make her aware of a concern or constructive suggestion that has come to my attention, but it will be her job to carry out the plan in bringing resolution to issues or making constructive modifications and not my job to tell her what to do from a micromanaging standpoint. This is in essence how decisions as a board member needs to be balanced in regards to input from teachers and parents.

12) How long have you lived in Birmingham, and how would you characterize the City's quality of life? How should it be improved?

I have lived in Birmingham for 50 years and I would characterize the quality of life as being good in regards to all of the positive steps we have made in all areas of the Birmingham Comprehensive Plan which was developed and approved by the Birmingham Planning Commission, which is also a part of my responsibility as a Birmingham Planning Commissioner. From my perspective as a citizen and as a member of the Birmingham Planning Commission, our greatest needs are to improve our schools, significantly decrease crime, and devote more attention to building up our neighborhoods in reference to street repair, lighting, blight and the like. I truly believe a top notch educational system will elevate the city to world class status as well, and with that being said education is the top priority.

13) What distinguishes you from the other candidates?

My experience and knowledge as an educator from being a teacher, assistant principal, personnel coordinator and hearing officer in Birmingham City Schools, coupled with my experience as a principal in Eufaula City Schools, and Superintendent in Midfield City and Greene County Schools distinguish me from other candidates. I have worked for elected and appointed school boards, trained them in their roles, and I have been certified by the Alabama Association of School Boards in Professional Development for School Boards, and the Birmingham Business Alliance, Birmingham Education Foundation and Alabama School Boards in the areas of finance, school board roles and ethical and legal issues. In addition, Alabama State Law requires that all Superintendents in this state be certified in finance and curriculum and I am also the only candidate that holds that distinction.

(14) What issue is not getting enough attention?

In my opinion, the issue in the Birmingham City Schools that is not getting enough attention is the lack of highly qualified and certified teachers teaching our children. Too many teachers are applying for alternative certification through the state department and in many cases they do not fulfill the 1

year or 3 year requirements of passing the state exam or completing coursework and thus have to be terminated. In cases like these you start over from scratch as a result of giving teachers an opportunity to become certified and also they have a bigger learning curve on the job as a result of not having the proper certification compared to someone who is highly qualified and properly certified. This issue is absolutely critical to the success of our schools and it is imperative that it receives more attention
